#### Definitions

**Filtered Search:** A filtered search can be applied using query parameters in order to obtain only the resource entities that meet the criteria defined by the filtering parameters included in the query request. Several elements can be applied to the filtered search. In that case logic, a logical AND is applied to combine the criteria (e.g.:?severity=<value> &status=<value>)

Attribute selection (Filtered Response Data): In order to apply a filter and limit the number of attributes included in the response, the GET request can include the "?fields=" query parameter. Several elements can be applied to the filter. In that case, a logical AND is applied to combine the values (e.g.:?fields=severity,status) will provide in the response only the values assigned to attributes category and channel. Attribute selection capabilities are the same for collections retrieval and individual resource queries

### **API CONFORMANCE TEST SCENARIOS**

This section describes the test scenarios required for the basic CONNECT certification of the API.

Test Cases must be executed in the order defined for each resource because the result from one of the scenarios will be input for the next one.

Requests must be addressed to the endpoint provided for certification, specifically they must be addressed to the URI defined by the concatenation of the {apiRoot} and the specific resource, where the {apiRoot} is defined as **{serverRoot}/agreement/v1**, where {serverRoot} defines the certification endpoint

WE describe below test cases for Agreement resource. For the Agreement Specification Resource, the test cases are identical (simple replace "agreement" by "agreementSpecification" in the examples.

#### Agreement resource TEST CASES

#### **Nominal Scenarios**

#### TC\_Trou\_N1 – Create new Agreement with minimum required information

 Send a POST message to {apiRoot}/agreement/ with the following contents in the BODY

```

- Wait for a response from the server with the following characteristics
  - Response Code 201-Created
  - Include a location header in the body set to /{apiRoot}/agreement/{IDtt1} where {IDtt1} indicates the identifier assigned by the server to the new Agreement resource
  - The response message includes all mandatory parameters (including description, severity and type that were not sent in the original request)
  - The body of the response matches the values set in the original request

- Wait for a response from the server with the following characteristics
  - Response Code 200-OK
  - The body of the response includes one Agreement resource with ID set to {IDtt1}, the same identifier as assigned by the server to the new resource created
  - The response message includes all mandatory parameters
  - The body of the response for the resource with identifier {IDtt1} matches the values set in the original request
- Send a GET message to /{apiRoot}/agreement/{IDtt1}
- Wait for a response from the server with the following characteristics
  - Response Code 200-OK
  - The response message includes all mandatory parameters
  - The body of the response includes a Agreement resource structure that matches the values in the original request

# TC\_Trou\_N2 – Create new Agreement with minimum set of parameters supported by server

 Send a POST message to {apiRoot}/agreement/ with the following contents in the BODY

- Wait for a response from the server with the following characteristics
  - Response Code 201-Created

- Include a location header in the body set to /{apiRoot}/account/{IDtt2} where {IDtt2} indicates the identifier assigned by the server to the new Agreement resource
- The response message includes all mandatory parameters that were not sent in the original request)
- The body of the response matches the values set in the original request
- Send a GET message to /{apiRoot}/agreement/
- Wait for a response from the server with the following characteristics
  - Response Code 200-OK
  - The body of the response includes one Agreement resource with ID set to {IDtt2}, the same identifier as assigned by the server to the new resource created
  - The response message includes all mandatory parameters
  - The body of the response for the resource with identifier {IDtt2} matches the values set in the original request
- Send a GET message to /{apiRoot}/agreement/{IDtt2}
- Wait for a response from the server with the following characteristics
  - Response Code 200-OK
  - The response message includes all mandatory parameters
  - The body of the response includes a Agreement resource structure that matches the values in the original request

#### TC\_Trou\_N3 – Search for Agreements with specific characteristics

• Send a GET message to /{apiRoot}/agreement



- Wait for a response from the server with the following characteristics
  - Response Code 200-OK
  - The body of the response includes at least two Agreement resources referring to {IDtt1} and {IDtt2}
  - The body of the response for the resource with each identifier matches the values in the corresponding original request
- Send a GET message to /{apiRoot}/ Agreement?status=Active
- Wait for a response from the server with the following characteristics
  - Response Code 200-OK
  - The body of the response includes one Agreement resource referring to {IDtt1} and there is no reference to Agreement resource {IDtt2}
  - The response message includes all mandatory parameters
  - The body of the response for the resource with identifier {IDtt1} matches the values in the original request

#### TC\_Trou\_N4 – Filtered retrieval of Agreements

- Send a GET message to /{apiRoot}/agreement/{IDtt1}?fields=name,status
- Wait for a response from the server with the following characteristics
  - Response Code 200-OK
  - The body of the response includes one Agreement resource referring to {IDtt1} and including only attributes name and status, matching the values in the original request

#### **Error Scenarios**

#### TC\_Trou\_E1 – Unknown Agreement identifier

• Send a GET message to /{apiRoot}/agreement/{IDtt3}, where {IDtt3} does not match any of the identifiers previously creted in the server



- Wait for a response from the server with the following characteristics
  - o Response Code 404-Not Found

#### TC\_Trou\_E2 – Invalid Request – Missing mandatory parameter

• Send a POST message to {apiRoot}/agreement/ with the following contents in the BODY.

```

    "status": true,
}
```

Notice that this request is missing mandatory parameter "name" but any other mandatory parameter could be used

• Wait for an error response from the server indicating the mandatory parameter is missing in the request

#### TC\_Trou\_E3 – Invalid Request – Missing parameter mandatory in context

• Send a POST message to {apiRoot}/agreement/ with the following contents in the BODY.

"name": "some name",
"characteristic":
{
"value": "coco"
}

Notice that this request is missing mandatory parameters "name" in the included sub object.

• Wait for an error response from the server indicating the mandatory parameter is missing in the request
