Value	ODA offers an industry-agreed blueprint, language and set of key design principles to follow. It helps address a wide range of challenges brought about by market, business model and technology changes, such as virtualization and 5G, which will impact every aspect of business, including a move to agile operations supported by a reimagined OSS and BSS. It provides pragmatic pathways from maintaining monolithic, legacy software solutions, towards managing nimble, cloud native capabilities that can be orchestrated using AI.
Strategy	TM Forum members are collaboratively capturing architectural patterns and solutions to produce the Open Digital Architecture as an industry agreed blueprint for the next generation of supporting systems. The project is delivering a model-driven and data-driven architecture that relies on metadata, microservices and a clear set of normalised APIs.
